The applicant agrees to and understands that the terms and conditions are those that are displayed on the BarterZone website and these terms and conditions may be updated from time to time and the applicant agrees to these terms and conditions at all times. The applicant understands that BarterZone will credit a member's BarterZone dollar account with the value of each sale supply made by the member through the exchange in accordance with the BarterZone terms and conditions and any other amounts as may be provided for in the terms and conditions of BarterZone.

The applicant understands that BarterZone will debit the members BarterZone dollar account the cost of each purchase made by that member through the exchange and the BarterZone dollar for any fees payable as part of that transaction in accordance with the BarterZone terms and conditions. The applicant agrees that BarterZone may, at any time, increase or reduce the applicants BarterZone dollar account credit limit, although it will not increase the credit limit beyond the level requested by the applicant and understands that BarterZone may at its discretion require the applicant to provide a guarantee, cash deposit or other security acceptable to BarterZone as security for the applicants performance as a member of the exchange.

In consideration for performing services specified in the BarterZone terms and conditions the applicant agrees to pay BarterZone a transaction charge at the rate of 8% cash fee of the transaction purchase made through the exchange. In no circumstances is BarterZone (or any other person) obligated to redeem BarterZone trade dollars for NZ cash currency. All members agree and understand that \$1 BarterZone trade dollar is equal to \$1NZ Dollar for valuation purposes. BarterZone will send each member regular statements by way of email showing their barter and cash account balances, and provide facilities for the members to download their statements and invoices from the BarterZone Website. Any cash amount owing to BarterZone must be paid within 7 days of receipt of that statement or sooner if requested by BarterZone.

The member signing this membership form unconditionally and irrevocably personally guarantees to pay to BarterZone any moneys that may become due under this membership agreement with BarterZone as they fall due. The liability of the Guarantor will constitute a principal obligation of the Guarantor. As Guarantor I acknowledge I have read the terms and conditions of this agreement and understand them.

All liability of any kind of BarterZone to any member with respect to the services provided by it or other BarterZone members (whether arising under the Consumer Guarantees Act or any other enactment or otherwise) is excluded to the fullest extent permitted by law.
